AGENCY OVERVIEW

The Fair Lawn Police Department (FLPD) is located at 8-01 Fair Lawn Avenue, Fair Lawn NJ, 07410. Main line: 201-796-1400, 9-1-1 emergency.

The department serves a community of 35,564. ¹ The daytime population exceeds this count by virtue of commercial establishments, industrial operations, school services, and people in transit.

As of 12-31-2024, the total number of full-time sworn personnel is 61. There are 12 part-time Class III Special Police Officers, 11 part-time Class I Special Police Officers, 5 full-time public safety dispatchers, 2 per diem dispatchers, 3 full-time civilian staff, and 2 part-time civilian staff members. In addition, there are 45 part-time school crossing guards, tasked with safety crossing children at arrival and dismissal times throughout the year that are managed by the FLPD.

PATROL DIVISION

As an agency, the Fair Lawn Police Department handled 22,558 calls for service in 2024. The patrol division dealt with the majority of the calls for service. The patrol division is commanded by Captain Joseph Dawicki and consists of 4 Lieutenants, 4 Sergeants and 28 Police Officers working across 4 different 12 hour shifts. Some of the functions of the division are:

- To provide police services 24 hours a day
- Investigation of crimes
- Response to all types of calls for service
- Motor vehicle crash investigations
- Directed patrols for various law enforcement efforts
- Community engagement
- Business security checks after hours

DETECTIVE BUREAU

The FLPD Detective Bureau is under the command of Detective Captain Ronald Patterson. The detective bureau is responsible for investigating a wide range of issues within the Borough of Fair Lawn. Detectives assigned to the Bureau investigate crimes reported to the department. Some of the more common type of crimes our detectives investigate are thefts, burglaries, robberies, fraud, narcotics, sexual assaults, and juvenile investigations. Some of the other functions the Bureau is responsible for is conducting background investigations for police applicants, firearm purchase permits, and conducting Internal Affairs Investigations. Members of the detective bureau are also tasked with maintaining compliance with local, county, state and federally mandated training, via classroom, virtual, and tactical hands-on training.

In 2024, the FLPD Detective Bureau investigated 319 crimes, resulting in 71 arrests. Some noteworthy cases:

- In January Officers responded to an altercation at a residence. During the investigation, which revealed signs of a struggle, there was a significant amount of marijuana product in the residence. Detectives were summoned to the scene which resulted in the seizure of 35 pounds of marijuana. Charges filed for narcotics distribution.
- A victim reported being accosted by a ride service driver in April. After investigation, the driver was charged with sexual assault and sexual contact.
- In July detectives were investigating two individuals who were seen entering a motor vehicle. They were followed and ultimately arrested in Ridgewood, with the victims' credit cards in their possession during the course of committing a fraud.

COMMUNITY POLICING UNIT

The Community Policing and Traffic units are under the command of Captain Brian LaRosa. These units provide a multitude of vital services to the community. On any given day, officers from community policing can be found performing some of the following tasks:

- Public speaking engagements, to educate the public about a wide variety of topics such as pedestrian safety, school safety, crime awareness, and fraud prevention and other timely information.
- Law Enforcement Against Drugs (LEAD), offered to 5th and 6th grade students.
- Citizen and Junior Police Academies, held in the spring and summer yearly
- Police Cadet Post 1126, open to high school and college age individuals who have an interest in law enforcement. Monthly meetings and training are held, as well as a yearly summer week long academy. Police Cadets are also visible around town at special events under supervision of Sgt. Eleshewich, Sgt. Macys, and Det. O'Shaughnessy.

- Citizen ride-along program with officers
- Street fairs, including National Night Out held every August
- Coffee with a cop, citizen outreach

TRAFFIC DIVISION

The FLPD Traffic Division consists of Sgt. Sean Nagle and 4 dedicated officers under his command. They are responsible for addressing a wide variety of traffic related issues to include:

- Motor vehicle enforcement
- Receive & address citizen complaints
- Work zone safety projects to improve traffic management and safety at construction zones
- Crossing guard supervision. In 2024, Fair Lawn had 45 crossing guards
- Speed monitoring & surveys via pole mounted radar equipment
- Timed parking enforcement, via the part-time parking officer
- Child seat installations, 30 were performed in 2024. To schedule an appointment for a free install, call the main desk at 201-796-1400 on Wednesdays or Saturdays from 9am-1pm to confirm availability.

HONOR GUARD

The FLPD Honor Guard was formed in 1973, and is currently under the command of Captain Joseph Dawicki. For over 51 years, the Honor Guard has represented both the FLPD and the Borough of Fair Lawn with distinction both locally and regionally in the tristate area and along the eastern seaboard of the United States of America. The Honor Guard serves to memorialize law enforcement officers killed in the line of duty, our nation's Veterans, and also for momentous occasions such as police graduations and other ceremonial functions.

POLICE RECORDS

The FLPD Records Bureau is staffed by two full-time civilian employees and one part-time employee. The records bureau is responsible for maintaining, filing, sorting, storing, and disseminating all records created by the FLPD. This includes all incident reports and related paperwork such as arrest records, photographs, motor vehicle crash reports, property and inventory reports, and all other legal documentation that is required by the State and Federal Government. These documents are requested on a daily basis for the following needs:

- Legal discovery for prosecution & defense
- OPRA requests, 284 fulfilled in 2024
- Municipal, state, and federal agency requests
- Insurance companies
- Involved parties to police incidents

In addition, the Records bureau is tasked with:

- Borough parking pass sale & registry, 731 yearly permits and 90 monthly permits issued in 2024
- Solicitor permit sale & registry, 26 processed in 2024
- Processing 179 citizen reports in 2024
- Record & background checks
- Monthly FBI crime statistic reporting

CLASS III OFFICERS

FLPD Class III Special Police Officers are under the command of Detective Captain Ronald Patterson. They are retired law enforcement officers in accordance with <u>guidelines</u> from the State of New Jersey Police Training Commission who are tasked with providing security to the Fair Lawn Middle and Elementary Schools. Officers work closely with school personnel to ensure a safe environment for all. The unit has 12 Officers assigned part-time, and each public school is covered on a daily basis.

CLASS I OFFICERS

FLPD Class I Special Police Officers are tasked with providing support to the Police Department in the following disciplines:

- Courtroom security
- Special event security & crowd control
- Weather related emergencies

In 2024, the Class I officers worked hundreds of posts throughout town for a variety of events. Sgt. Eric Eleshewich is in charge of the Class I officers, all 11 of which are assigned part-time.

COMMUNICATIONS

Communications handles in excess of 100,000 telephone calls and 9-1-1 calls per year. The volume of radio traffic is even higher. The communications room is staffed 24/7 by five rotating dedicated full-time personnel and supplemented by per diem staff and police officers on occasion. You can count on them to get the officers heading to your situation!



PROPERTY & EVIDENCE FUNCTION

In 2024, the FLPD property & evidence function handled an intake of 373 items of property. One item of property technically may have dozens of items associated to it however. Property ranges from evidence to contraband to confiscated items and found property. The total number of items currently in inventory is 7,174. In addition, there were 687 items removed from inventory and disposed of and 43 items returned to their owners.

- In March, Captain Joseph Dawicki graduated the 289th session of the FBI National Academy in Quantico, VA, the 4th officer in department history to do so.
- In May, the Department regrettably announced the passing of SPO Class I Nicholas Magarelli Sr.
- PO Boskovski resigned to take a position with the Bergen County Prosecutor's Office in June.
- In August, the FLPD swore in 2 new recruits, Patrick Jablonowski and Vincent Messina to attend the police academy.
- PO Koenemund resigned to take a position with the Paramus Police Department in October.
- In December, the FLPD swore in PO Diosnedy Lanfranco, a lateral transfer from the Paterson Police Department.
